## **Enrique's early days and from Spain to Mexico**

Enrique was born in Madrid, Spain(possibly on a boat when his parents and family were moving to Mexico) and his parents were from Madrid, Spain. It is said they had moved to Mexico City, Mexico and he had lived at Veracruz, Mexico. It had said he was born in the year 1900(possibly 1898) and recently it had said he was born in 1902 and 1905 and his death certificate had written in 1905 and it could of been misswritten and his brother Antonio(later who had became Mexico Ambassador to the United States) that year(in 1905) was born that had written in a article on a webpage.

In 1917(or1919) Enrique had been listed to the Mexican Army and he had a girlfriend at Spain and in 1917 he visited Spain on a boat to meet with his girlfriend and bring her to Mexico with him and her last name was Fidalgo and he married her and they lived together too and that was Enrique's frist wife. His second was Journourro(?) and third wife was Mrs. Madero(or she was the second wife possibly) and she was a niece of the Mex. President Madero. Meanwhile his brother Carlos had study as a pianist in the 1920's and later had scored on several songs. And one of his sisters had moved to Houston, Texas. In the beginning of the 1930's Enrique had first became a Mex. officer for the army it was told. He was a sargeant(sargento) to colonel(coronel) from 1930-1949. He had study as a doctor in the army and got his BAA degree. It had said before he had traveled to Tijuana, B.C. Mex. and stayed there in the 1930s as a officer there. His mothers uncle in 1933 had got into the Mexican President Elections and had ran for it and stopped when he had not appear at a meeting to make his speech for a really good reason.

### **While an enlisted officer and from the year 1933 to1944**

Enrique had married again and the lady his 4th wife was probably Giurr. or Equirre and his next wife could of been one of those names or Celia ( Cecilia) Narvaez Herrera and she was the sister of my grandmother who he had married later.Enrique had spoke Spanish and he had learn or study English. And he had probably learn or study the language German in the late 1930's or early 1940's and he had study Portuguese too.

In the 1930's it had said that (as a officer) he had stayed in Tijuana for a little while then. Enrique Oldest daughter was probably Mallia(Pab?). And she in the early 1940's had moved to the U.S. with her husband(a german) and she had worked in Hollywood as a custume or clothes sewer for the celebrities(Stars). Enrique son Enrique(Geeque) Juan had enlisted as a pilot in the U.S. military and it had said he was enlisted as a soldier and a pilot and his brother Yayo was a sailor in the U.S. Navy and they both were stationed(serving) at Pearl Harbor when the Japanese had raided(bombed) the place(base). Enrique(Juan) had went to war as a enlisted pilot when the U.S. had went to war with the Japanese after they had declared war with them. Mallia husband Ronnie had been in Germany serving as a nazi pilot during the early 1940's. And they had a place at Colorado, U.S.. Enrique(Juan) later he had enlisted in the Korean war for the U.S. army as a soldier.

And his 6th wife could of been Equirre if not she was the last wife or it was a lady whos last name was Gomez. Enrique had learned or study the Japanese language during the 1940's. And all his wives he had been with they had childrens(sons and daughters). His brother Antonio had travelled to

places like to the U.S. as a Mex. ambassador he had travelled with Pres. Camacho and with Pres. Aleman and travelled with him(Aleman) to the U.S. for a meeting at(to) the White House for the Presidents. And he had other meetings alone at the White House. Antonio first year as a ambassador was in 1943.

Enrique(Juan or Carlos) had received a medal(POW medal) for the Japanese & U.S. pacific war. He had flew his airplane to war and after he had landed his plane probably maybe because he had an accident with his plane he had went on foot on ground(or travelled) as a soldier then and later was captured by the Japanese soldiers and was imprisoned and was hanged and torched by them and had escaped from there and from a camp there was probably or by the place(a wooden bin/shed). And he had probably been at the POW camp on the island and after he had escaped..

### **1947 Meeting**

Enrique had been married to a lady again in 1947?(1940-1947) and her last name was Cruz. And then he married a sister of Celia and her name was Eluisa Narvaez Herrera 1947 and she was the 8th wife (Elusia was my grandmother). Enrique had stayed at Mazatlan where he was stationed as a officer at a mexican army base. Meanwhile my grandfather then was probably learning Italian then. His first kid was "Garde" Edgar(it is said that Garde he was left to be taken care by Eluisa..). He was born Feb. 1947 at the military base at Mazatlan.

In the month of March(May) in 1947 the President of Mex. and the President of the U.S. had a meeting when Pres. Truman had went to visit Mexico. Enrique had been there when the U.S. Pres. and Mex. Pres. had met each other in a crowd of other officials from the U.S. and Mexico. Enrique's brother Antonio the Mex. ambassador had been board by the plane when Pre. Truman had aboard from his plane when waiting for him(to meet him). Enrique was with his other officers and cadets of the mex. army and Antonio had came along behind U.S. officials one or two Admirals and Truman and his secretary(or body guard) and his ambassador had been there with the Mex. Pres. Aleman when they met. Other former mexican presidents had been there when they were all invited at the meeting. Antonio had taken a visit to the U.S. to have a meeting with Pres. Truman in Baltimore, Washington D.C. at the White House and inside the White House Theatre. They had sat down on the chairs(their seats) next to each other and talked about their meetings and issues. It was told to me that Antonio(my father had mentioned Jorge and not Antonio when him(his uncle) and the President had met. It was know by my other uncle and brother that they said Antonio was who met the president and he was a ambassador and etc.) and Truman had met each other and had a meeting and they sat down next to each other and had an interview and they(publishers or camera mens) were publishing it and they had one publisher next to them typing the words said in the interview on his type writer and they Antonio and H.Truman were talking or discussing about political and economy issues and etc. about the two countries(Mexico and U.S.). And it is said it was at Mexico, Mexico City and they had published a book about their interview and it was called "Presidente Harry S. Truman conocer Antonio Espinosa de los Monteros"(?)(La vista de Presidente Harry H. Truman y Antonio Espinosa de los Monteros).

### **Enrique and his family from Guadalajara to Mexicalli and to Tijuana**

Enrique Adolfo then had a home in Guadalajara and while he was staying(living) at the mexican military base at Mazatlan. He had been at the military base there training and ordering his soldiers and with his officers and they were busy keeping the army together and he had been busy working with his patients giving aide and surgery's as a doctor and teaching some too. He had served as a colonel(coronial) from 1948 to 1950. He had a second son from Eluisa born in the year 1949(or 1948) and a third son born in 1951. They had moved to Baja California at Mexicalli and moved in a house he had it built(or rebuilt) on a desert like land by the hills. The house was a small house size of a square and not much more of a square too from the front. Two plants he had planted on separate sides of the front of the house yard. He had a first daughter from his wife then and they lived in Mexicalli for a little while and Enrique lived there with them when he wasnt at the base or traveling. He had taken his son Garde(Edgar) to the military base with him to visit then too. Garde was living there and at Mexicalli when he stayed with the family.

In 1951(or1949-1954) Enrique had found another place to live at and the family went to move there at La Presa(Upper La Presa), Tijuana and the house was a average nice place and the front yard had a brick(cement wall) for a fence and the entrance there. The house was made of wood and cement(or brick) around the house. They had lived uphill and at the first block at the back of the little town at Upper La Presa at Juarez Col.(campino) and near large hills and a lake and hills all around the lake from the left side to the back all along from the whole area like in rows from Tijuana area to the beginning of Tecate city.

### **Enrique a General of Mexico**

Enrique had became a General in the year 1951(or1950) In 1952 on the month of June Enrique Adolfo had a fourth son from Eluisa and a fifth son later(in the year 1955). And most of his sons and a daughter from the 8th wife was born in the city Mexicalli or Tijuana. Meanwhile he was a general(Brigadier General/Brigagier(?) General; spanish word) he had stayed at the military base and else where while serving in duty and he had came to stay and visit his home at La Presa with his wife and childrens only for very short period of days or temporary because he was busy working at the base or other military sites and government offices and living back and forth from place to place and he had travelled else where out the country and he was teaching too. It is said he was wanted by other generals and higher rank generals and they wanted to get him and kill him and when one general wanted to kill him they had followed and went with it and had to with the plan too(?). Meanwhile when Enrique went to the base he had to hide from them. And they were trying to kill him when he went to the base if they could find him.

Enrique had planned to do something to not let them know where he was(or hiding) he had planned to dress like a woman when he went to the base and he had put on the clothes of a woman and a wig( brunette color wig he wored too) and he had to put on makeup and his own fake woman breasts every day he had to go dress like a woman and hide from them at the base. It is said it had happened during one year. One year was mentioned 1955 when my father was talking about this story and a picture of him when he was a general in 1955 and why in the picture his skin looking lightly colored like after being blushed a lot of times. Meanwhile to when he had went to the base like that he had taken his young son Garde Edgar with him too before. Meanwhile then and earlier the PRI meetings and the generals and the goverment of Veracruz meetings and arguments and fights had occurred and small riots.

Enrique had travelled to Espana(Spain) and France and other countries later and then. He had learned French well good and he had learned chinese and communicate with the chinese officials who had came from China and when the Ambassasador of China had sent his embassys and other officials to Mexico to visit and Enrique had to communicate with them when they met for meetings for the chinese and mexican officials and for the business trades of imports and exports of products and foods trade.

Enrique had planned to build a Castle/Palace at Tijuana on a hill that was the only constructed/build home (house/Castle..) or first home to be build on the hill made of european/american housing style. He had a son born inside the castle his son Carlos his fourth son and it is said the castle was first started to be build in 1952 or 1955. My father had told me that he was born inside there. The castle was build out of brick and cement and wood boards for the inside framing too in one section like a regular European castle and the other section was build with cement for the walls and board framings around and inside the large balcony on the upper floor and a template or round cylinder architected build section of the building thats is part of the roof. He had a underground secret hidden base build under the Palace(or Castle) for his military control base and board room for meetings.

He had a best friend in Tijuana and he had visit him and had visits at his castle or inside his base. His friend had met their with him and met their to wait for him(Enrique) when he comes back from their or probably someplace else. It is said little or some problems had came and he was involved from little crime scenes from others may try to cause or cause or from Enrique. It is said by my fathers ex. girlfriend/wife Juanita said that he had he had kept people on the ground in a dugged wide hole(pit) and shot them or had them shot and killed while he was in service for the mexican army and with his officers too and etc. and Juanita said he was a crazy man to and he was angry alot and got very angry too and they had talked he was nice too and good of this etc and when he talks and gets mad it is wrong?. My father had told me he was a very smart man and good too?. He had visited a place where generals and officers were because to ask about his father for info. and for films of him and officers let him in the gates and he had talked to one general for information about him and he(the general) said that your father Enrique Adolfo Espinosa de los Monteros was a very smart man and good man. The general possibly knew my grandfather. He had let my father to watch films of him and they would allow him(visitors related members of officers etc.only) to go and officers would be there to go with Carlos to escort him to escort him to the room to watch the film(s).

Enrique Adolfo continued serving in the mexican military and he had served as a general and he been made a rank higher as a general to a Brigada General(Major General or a "General" the name would be for a general of another rank of the 5 generals) in the year 1955. During the 1940's to the 1950's the rank orders for the generals were changed from 5 different generals(or to 5 star generals) to 3 different generals(or to 3 star general) and Enrique Adolfo was a 2 star general then. In in 1955 Enrique Adolfo had a fifth son and his last son from Eluisa and all his children. And his last son name was Tolio Ivan Espinosa de los Monteros(all childrens last name from Eluisa and Probably Garde last name was spelled with a "z" at the second last letter from Espinosa.). The only remembrance other than information told of our grandmother and grandfather living together and being together at home or traveling is from a photo of them together sitting down on a couch inside the living room of their home at La Presa and only picture that the family had them together and one of my uncles has the picture or had it (when it had been thrown away with some other pictures (that was his) in a bag from a ex.

woman. Photos were of his father at other countries when he was traveling and one was a photo of him with some chinese officials and probably the ambassador too when he had traveled to China to and he had met Mao M.(the chinese president) and he had taken a photo with him it had said something like that(?). It is said and told by others(mexican officials) that they heard him communicating in chinese with the chinese officials when they met at Mexico. They had come when the chinese ambassador had sent his officials to Mexico for Mao and they had come to Mexico for the foreign trade from the two countries importing and exporting foods and products and for a meeting for that. This was during the mid 1950's. He had went to Espana(Spain) to stay at Madrid at the palace(Plaza de Madrid) the capitol of the country. He had stayed there at the hotel room because he had visit for a meeting with other officials of the government and when Mexican officials had visit the country for a meeting with the Spaniards and Enrique had met the leader Francisco Franco and Enrique had met with other officials and probably Franco at a bull stadium when Spain government had a election for a king of Spain(it was said ?) and when they need a king when they didnt have one for many years from the late 1930's to the 1950's. It is said that Enrique was a candidate to run for a king of Spain or it was a candidate for president of Mexico. His brother Antonio was a candidate and was second to a president(or Rep., Liberal, Dem. or Independent president for one party)Palacio(?) for a race. Enrique had study French and learned it well and it is said he had spoken that language good to others and spoken the words perfectly for that language. And said he didnt make a mistake pronouncing(translating)the words.

Enrique Adolfo brother Antonio whom served as a ambassador for 8 years and his last year was in 1951 and Mexican president Miguel Aleman last year as the president was in the same year too. He had been in one party and a secretary(an inmanisty to the..) he had several men(Generals and other mens) arrested for the kidnappy of several citizens and officials(?) led by the general then Guzman at Mexico City and some of their names were gen. Ramos P., gen. Aguilar(?),and Gen.Flores(one brother of another general) etc. after his last year serving as president. Antonio Espinosa de los Monteros "The Don" the ambassador was a partison of the "The Henriquistas Generals" that Guzman had started. This had occurred after the year 1951. The secretary of interior Alvarez had attacked a speech to the ambassador Antonio and that's when Antonio came up with an outstanding speech on a broadcast radio saying "A Mexican traitor is not worthy if he plunges a knife in the back into the heart of the motherland"...

And while a general some generals had put an ad of general Enrique that he was wanted and they had his picture put on the ad too when he was wanted by one general(or all generals one year) in 1957 or later. Adolfo Ruiz Cortines had been the president of Mexico and was president after Aleman was president. And when the president heard that someone(one general) wanted to kill Enrique he had made sure it didnt took place and stood for that and let it know in congress(or in a meeting)and was with this issue too. The president was a friend of Enrique and he wanted to help him. Enrique had been close to the president of Mexico too and it had been told by my father too. in 1955 Mexican women on July 7 voted for the first time in a congressional election. R. Cortines had promised anti-corruption and anti-profiteering campaigns and a good neighbor policy in foreign relations as the basis of his administration. He added "freedom to criticize the government" to a list of guaranteed freedoms: thought, press, religion and economic and spiritual liberty.\*

Enrique base was at Mazatlan and was in charge of that one and he had owed most of the area in Tijuana and to Mexicali and little of surrounding areas when he was a general and the area that was his(it is said)and his zone area that is for a general(a general who had been in charge of his(an)

zone area and a Intelligence of a sector of Mexico City was a commanding general). Enrique was in charge of all the prisons(or it was jails) in Mexico it was said. Enrique had his own school to teach to during the 1950's and later. Meanwhile he was married to Eluisa still and he had married again with another lady(Equirre her last name) and he had two wives then he was married too. His castle/palace was done (build) in 1957. Equirre was his last marriage(wife) and they didnt have any sons or daughters together(it is said). And they got married in the year 1955.

Pres. Eisenhower Mar. 10 signed the bill , which permitted mexican farm-laborers to enter the U.S. through Dec. 31, 1955. It provided that the workers would be recrited at 6 Mexican border stations and paid not less than the prevailing wage received by Americans.\* He with a Mexican President (A. Mateos/R.Cortines?) when crossing to the Texas/Mexican boarder and met at the Ciudad Acuna pass/river? to sign an initial agreement to build a Dam there. Earlier Adolfo R. Cortines and met with D. Eisenhower in 1953 on October 19 to Dedicate the Falcon Dam on the Rio Grande river of the Texas/Temaupipas boarder. The Dam was first started on the month of Dec. 1950 and done on the month om April 1954. R. Cortines Foreign affairs,Interior,Hydrauli/onic(?)(Chavez) cabinets members and probably Gen. Enrique had went to that meeting?. While other meetings by the presidents had then.

Other News- Mexico City was battered by labor and studentviolence in 1958, R. Cortine last year in office.(He had been Labor Secretary and a supporter of President Madero earlier in his years before presidency.). there were 2 major strikes: (1) State telegraph workers struck Feb. 5, and rejected Feb. 15 wage increase offered by Cortines. The strike was solved through Ruiz Cortines mediations toward the end of the month.(2) A 1 day rail strike with daily work stoppages ended june 30 after R.C. agreed to study workers demands for a 250 peso(\$20) monthly raise... Rioting students seized buses in Mexico City Aug. 23 in protest against a fare rise that took effect Aug. 19.

Some of the vehicles were hidden within University City, an autonomous organization barred to police and Federal police reclaimed 18 buses late Aug. 23 but they rioters still held 141. An estimated 100 persons were injured in clases between drivers and students and in accidents involving student-driven buses. Riots also were staged Aug. 28-30 by wilcat groups in the Union of Pemex workers...

During the 1950s the government of Mexico had reject the so called"Spaniards' term for relations of the Spanish-Mexican govern./officials meetings?. There were other Terms for groups(?) the Francis, the "Froncois" and the "Fatigue". Enrique had tooken visits to Spain from Mexico to meet with the spaniards officials and especially to meet F. Franco and he was a spaniard born and a Mexican citizen and when the Franco "Francisis"? or "Froncois" term from people of the spanish/mexicans occured during the 1950's.

Enrique later in 1959 he had became a step higher for a general. And my father Carlos told me he saw a picture of my grandfather as a general wearing the same color suit(not the blue suit..) he wored as a general from the other picture and he was wearing(had) more stars on the shoulder strap of his suit and they were across it and little stars like the stars he had wored on the suit on the other picture. He had said then that 4 stars was the most then and his brother Rene had said too. And he said that he was the highest rank general or kind of general for a general that wored the silver stars and his brother Rene had said this and told him too. He was the general of the army and the term for the general he was and when he became General of the Army for Mexico after he was a Brigada General and their was a a Chief of Troopers and a kind of general a rank after the silver stars generals and had

read or view in this big book of countries military or in a website for the military orders or ranks and view from a picture or from older mexican movie films of the generals and the other(Chief of Troopers?Parachute) the color of their suits and generals then and from the films it showed they wore somekind of green colored suit and the other the Chief of Troopers a blue(Navy/Pantholo blue) suit. If our grandfather suit was blue for the military then he was a Chief of troopers(Chief? de Troopers) and if the same color general suit green he was a General of the Army or a General(Brigada de General) that he was and the stars were more from two to four for that kind of general. "General de Ejercito" is the spanish term for General of the Army.

### **Enriques Last Years 1958 to 1959 as General**

Meanwhile as General and a citizen Enrique had been with other officials from the governor of Baja California and from Mazatlan and Mexico City to etc. and they had been involved from building business and money trades from the governor of Baja California B.C. and for economic growth and land. Enrique had a condition of cancer problem on the neck later and was teaching some his last years.

In 1960 the Artist David A. Siqueiros recently elected secretary-general of the Mexican Communist Party was arrested for allegedly organized a riot that Leftist students rioted in Mexico City in the month of August.

Earlier a general strike by citizens of San Luis Potosi had been halted Dec. 9, 1959 by a truce arranged by the Lopez Mateos administration. The strike had been started Dec. 2 to force the dismissal of San Luis State Gov. M. Alvarez. An election held Dec. 7 for mayor of the city of San Luis gave more than 26,000 votes to independent candidate S. Nava Martiney to 1,683 for administration candidate F. Gutierrez Castellanos. 2nd Secy. Nicolai M. Remisov and military attache Nicolai V. Aksenov of the Soviet embassy in Mexico City had been ordered Mar. 31, 1959 to leave Mexico because of their alleged involvement in a nationwide railroad strike called Mar. 25. It was charged that Demetrio Vallejo Martinez, secretary general of the R.R.W.U. and ex-Comm. Party member, had been in frequent conferences with them both. Enrique had been in office in Mexico City of the intelligent sector rooms and other offices and with some(official)members and others who were there then in 1959 for a little while and even though he had been at his home in Tijuana and visiting his friend or friends in Tijuana.

Then in 1959(or could of been later) Enrique Adolfo Espinosa de los Monteros was in the hospital and he had a photo taken of him inside the hospital(?). He had taken a photo to have copies printed for each of his childrens from Eluisa(etc?) and have it sign to them and because he was in the hospital sick and because they could have a photo(last photo) of him because he knew he was dying (from cancer on his neck). Before Enrique was in the hospital he had went to visit his friend and because to meet him that day before he had passed away and when Enrique went there he knocked on the door and asked for someone for his friend and it was a wife(?) of his friend and he had asked for his friend Sr.(?) and when his son was comin. And the lady had told Enrique "He's not here he had been gone.." Then Enrique had went to get a cigar(or had a cigar after he had got it) out of his car from a pouch of the side of the car side door(?) and he went to the lady and asked her if she can tell his friend "Too enjoy smoking this cigar(the whole cigar)" for him and when he gave the cigar to her and she said yes and I will. His friend was probably at a factory or building shopping or at work to be there that night. Then it is said that Enrique had passed away around 30 minutes later. And when the ambulance had took him to the hospital the news(Noticias) reporters had came all around where he was going and at the hospital



when they took him inside and news came on live on television(televicion) for him when he died and the news was on every spanish televised channel for his death. He had died from cancer.

They had his funeral at a mortuary in Tijuana near Diaz St.(?) and by the only Main St.(long main street) around there in Tijuana and there was 2 really Main St. in all Tijuana. There's 3 mortuaries on the same street and the other two were older ones. They had come in cars, limosines and etc. down that street and the street on both sides of the road was filled with cars and limosines and etc. Many people had arrived. Government officials and other generals who had come in their government cars and limosines and many officers and related family members had come too and some in their limosines too and black or white cars and other loved ones. They had military officers to guard the entrance of the mortuary and Enrique's sons from his 4th wife had went and Yayo, Juan Enrique(Enrique Carlos?), Amalia and their mother and his oldest daughter Marilia(?) from his 2nd wife and she had probably came( her death could of been before the year of his death and she wasn't there.. ). Then Elisa had went to visit the mortuary and when she was going to walk in the main entrance of the mortuary gates (it is said..) that the officers that were there wouldn't let her through(inside) and she had waited at the side of the gates and she left later(?). They 'the camera film makers' had been there and filmed the burial of Enrique(passover/moment of peace of the gathering of family members and loved ones).

Elisa had continue her life raising her six childrens and they had went to school and they later went to a federal school in Tijuana and some of them had grew plants in their backyard to sell them for some money. Enrique had left his newer car there ( a 1957 Ford/Chevy and it was one of the first ones of that kind made and he had bought it from a factory in the U.S.). He had left two other older cars there one was some kind of ruined 1933 orange/brown chevy and the other was an average still built 1931 Ford(T?A).

It is said that he had buried a box of Colateral/suviniors underground before he had built a small house at the side of the yard over that. The family had not gotten much or nothing that was left in Enrique's savings inside the bank and it is said that the government had taken his savings and kept it for companys and etc. And later during the 1970's it is said that the castle that he had built it had been sold to someone(rich man) and the money went to someone else and the family of his fourth wife. The place had been closed up a little and probably hadn't really belong to no one else. Elisa got job later at a laundry business. And her son Garde started to work on motorcycles and parts and cars too at his friends fathers moto-cycle shop at La Presa across the road by Cuautemoc st. there. His their second oldest son Guillermo had learned to cut hair and later became a barber and he had kept the 1957 green/white ford and sold it. Her second oldest son Rene was in sports during his school years and had many trophies and he left to the United States and enrolled in the U.S. army as a soldier and later an officer for the military. Garde had his own new 1968 Harley-Davidson motorcycle and he and his best friend road on the road or highway together most of the time the two of them only. They drank and enjoyed nature and road ride on the road. His friend had passed away that year in 1968/1969. Garde and his friends(other friends) or compadres had went together or met each other at the park across the road from his home and parked their autos or motos their and enjoy their music and fix parts or do auto mechanics and they drank and with others they(or Garde) knew too and visitors they got to know a little more and sometimes there was a party at the park from someone from the neighbors and from Elisa or family and at her home she had a party and Garde friends and her friends and family members of theirs and the neighbors had came to the party and visit and visitors or muchachas/girls and senioritas had went to visit or to talk to a guy or for a date and Garde and his friends had went to the lake downhill to have to have a drink or some kind of activity and for a swim in the water and walk to other of their locations or to have some other gatherings too or to have a girlfriend with them for a lovers

together alone moment of peace there. Garde had been to the taco stands or the beer?cervesa stores to talk to his friends or others that are there and to meet with the workers there and maybe for some mechanic when someone needed a mechanic. Garde and Carlos had met there together to have a drink and eat tacos and to talk to their neighbors and friends and Tolio had went or met with Garde there for a drink etc and to have somekind of other enjoying activity for them and with their friends and when Tolio is out of jail too and Garde had been in jail for a while after the early 1980's to 1993 after he was in jail and from a prison on a island from the coast of northern Baja California near the Rosario and Tijuana city of the coast. Eluisa had some partys during the years too and the family had the partys for her birthday too. And Enrique's son from his fourth wife Enrique(Geeque) had served in the Vietnam war and dismissed later in 1974/1975(?) and he had married a lady who was a daughter of a Japanese man who was a high rank officer for the U.S. Navy and he had his own ship. And his brother Yayo had lived in West Covina and after he had served in the Navy and he had a job as a security(IINF?) clerk at the the L.A. county jail and had other temporary jobs. He had a family and been married with 5 childrens or more and Enrique(Juan) had childrens had they had lived in Japan. And his oldest daughter from his second wife had lived in Colorado and had a family and she had passed away at a early age in the 1950's. And his other daughter Amalia who had married a man from a military camp and had married twice. And she had many photos of her dad's family and more and she had lived a regular life and she had a job and studys a lot from her bible and last lives in San Diego. She had stayed with her father before for some years during her adult years too. Garde(Edgar) had been married to a lady from Tijuana and they had 4 childrens together and they had lived in L.A.(West Covina) and the mother and childrens only later and with their uncle. He had met another women later and probably had married her for a few years and had childrens too. And their(Enrique and Eluisa) second oldest son had learned to cut hair from a friend of the brothers in Tijuana and moved to the U.S. and got a job as a barber. And he had kept the 1957 green and white Ford and sold it. He had many ladys and had childrens with them and he had married 3 or 4 times and he had childrens with one lady and later he met a women who had lived in Norwalk and they lived in Santa Ana and they had one daughter and one son together and was married. She had been the cousin of the second wife of Garde and another wife of his other brother. Garde oldest son had later during his early age years had been in a car recked that had him sent to prison and he was the oldest of the grandsons and daughters of Enrique and Eluisa and Guillermo oldest son had lived together with his other brother and later they left and lived without their dad. Guillermo had many childrens(19 to 21 childrens). He had married a women who had lived in or near the city of Norwalk and raised in El Paso Texas and he had 1 daughter and 1 son with her. His last marriage he had been married 7 or more years with her. Their third children Rene had been in school and with some of his brothers and sisters and the others had been to the same school too in Upper La Presa and he had been invovled in sports and had many trophies and he and all his brothers and sisters had been to a Federal school in Tijuana next to the oldest main street roads there. And later he had moved to the U.S. and when he had enlisted in the U.S. army and served as a soldier and an officer(to a Master Sargeant) and served in the army in vietnam and other countries like at latin american countries. And he had met a lady in the U.S. or from camp in the army(?) and he had married and had 3 childrens. And he became a architect and a smart educated learner and into the marketing business(United States Chamber of Commerce). And their only daughter Thide had married a man from mexico and had two daughters and one son together and they had lived in Tijuana for many years of their life in a two-story house. And their fifth children and fourth son Carlos was one one who use to go sell plants to earn money and he became educated at school in Tijuana and when their were no school of the season he had went to travel to find his moms family. He had went to work at downtown Tijuana at a Bull Stadium as a Manuever Loader and Cleaner. And he had other temporary jobs during his child and teenage years. And he had moved to the U.S when he crossed the boarder and got a job and lived in San Diego and moved to Santa Ana with his brother Guillermo at his brothers friends home and they found a place together at a apartment there. They had married and had one son while living in Santa

Ana and a second a little later. And he had met the lady who lived in Norwalk too and was a cousin of the second wife of Guillermo and the sister of the girlfriend or wife of Garde who he had met just afterwards. Their relationship lasted a few years and did Gardes and his lover too. He had left and met some other lady later. He had a couple of relations with two other lady and he had one daughter from one lady who he was with before and who was close(friend) to the family of my dads and her grandmother and her family was close too. And he had one son from the other lady and four sons and a daughter from the first lady(his first wife). And his brother Garde had been with the lady who was the sister of Carlos and related to the wife of Guillermo. And they had childrens together. He had lived in a home with his family in a street in Norwalk and he had stayed at a friends home and in a tree house there. He was a mechanic fixing autos in his yard or at his neighbors and he was a mechanic at a shop near the house down the road/mainstreet. After he been together or married to her he had went to jail a couple or few years later for a few years and when his wife had been going to visit him many times and she was going for him too because he wanted to see her and be with her a lot inside the jail. And Carlos had came after a while to visit his ex. wife and kids once a year or on the holidays(mostly Christmas) and after a couple or three years later he came to get his kids( 1 or 2 mostly the times) when he was able and to take them(one) to visit their grandmother at Tijuana or at his home. And Tolio was the last son or children of Enrique and Eluisa and he had attended the same school and had temporary work during his teenage and child years too and he had friends he had hang around with and they had something to do as a group of friends or whoelse would do to enjoy themself together and they were just to chill or hip out kind of. And Carlos had a couple of his best friends who had died early in their years in the 1960's by a flood that broke out of a dam at the Tecate and Tijuana border next to La Presa. And Carlos had been their at the area and was near the hill when this happened and he had survived it by climbing to the top of the hill. And he had a friend that was a friend of E. Garde and the other brothers too who had lived in la Presa too and who had came with his father and mother family when Enrique and his wife Eluisa and their childrens had moved to Mexicalli(and Tijuana). And Tolio had one daughter from one lady and his first daughter in 1972 before Carlos had his first son with his first wife and Carlos may had other childrens or a children before his first wife and found out later not to long ago that one person may be his daughter. When the sons and one daughter of Eluisa of Enrique's were young they knew a older man who was a friend of the family and who lived near the neighborhood across the road(Centro/Peeli?) that Cuautemoc St. is the road in the neighborhood(calle of Benito Juarez) thats turns into too and down the road and hill he lived and the childrens got to know him till they were adults too. ( and he us to take care of them when they went there to visit or problems. Eluisa had been with one other man after Enrique had passed away she had gotten married with the him probably in the early 1970's and while living together there at La Presa and she gave birth to their first children together and their first daughter and they had another daughter and first son who were twins and their last daughter was born in 1973(or 1974). And Tolio had other sons and daughters from different ladys and he had one daughter and one son from this one lady who had(together) visit Eluisa and the family who had lived there then at La Presa before and really only when they were young childrens and may a few times only later and Tolios last childrens from one other lady all were from Tijuana and they lived with their mothers family. Eluisa and the family continue to have family partys and gatherings. She had worked at a laundry factory with one of her other close friends and one of her closest friends too till the 1980's. Garde came out of jail in 1993 and had met one of his sons when he was in jail for the first time since he was young and he had continued doing mechanic work on cars and worked on taxi cars for a job to make some earns and he died 14 years later and Rene had the same job and had three places later and one home hes buying and out of the military and married with the same lady for more than 20 years and Guillermo has his own other hair salon and a close friend for many years and who the family knew a lot. Thide and her family lives pretty close to each other and all had pretty good jobs or educated and her husband died 2 to 3 years later after Garde(Edgar) died. Eluisa had passed away in her home in 2009 and The year Thide husband Mr. Suarez(?) had died too.

The family had the wake and funeral for Eluisa in Tijuana and Garde was at the same place and their first church meeting (Funeral liturgy/Passover) was at the same neighborhood of their home is across the street from the park at the otherside. Many visitors had attended the church meeting for both. And at Garde burial site they had Eluisa burial site at the same site and they made one platt for both of them (they had added Gardes platt (script) and Eluisa's platt on one largwer stone (tombstone). After they passed away Tolio was staying there at the family house in La Presa after he was living in San Diego and left to Tijuana because for a court reason and one of the daughters of Eluisa (her youngest daughter) from the Serranos had stayed there and Tolio after Garde was not around and when their mother was living their and alive and around. And the youngest had came visit temporarily at the house and she came to stay after she had some kind of problem with a close-one with her arrest and when Tolio had just was sent (when the family agree to have him arrest at the house when they had an official paper sign of permission to have him sent to a criminal (perol) camp because of family act with problem from borrowing money and he had friends and others visiting at the house (when he was staying alone) and because they had came to bring small amounts of narcoutics/drugs more times than enough (when Tolio had them sometimes to bring some drugs and he had recommend himself to do that so too) and not only that too because they had came jumping over the fence and when Tolio wanted one of his amigos to break in through the window when the door was lock and because after the family had decided to have the house all locked up and Tolio later had try to get in and the family had closed up the house because after somebody or a family member and his other parter? had broke in the house from the front door when they broke the door handle latch and the handle that was not fixed or changed with a newer door handle set and they came in and took some materials and appliances from the living room and they took many clothes that was in the smaller room at the back that were in a walk-in closet and were hanged up and that many coats and jackets etc. that belong to our grandmother and many clothes they took from her bedroom and a closet. After the house was locked Tolio had stayed in the small house at the home and he had been in camp after they agree to keep him locked for a while and later they would release him every two weeks for two days only for what he needs to bring to support him and like food he can have at camp (dis./deten.? camp). The family would provide him some food to take to camp so he can eat there and he had sold some food for Etc!?! and asking the family (his brother and sister) if they can bring him another load of food and when he came to the house he had asked for more (money) and the family would provide him more food because they would want him to have food to eat because for whatever problems they had with him and what trouble he had or been in hes still their brother and the family would provide food during some amount of days or weeks only what he needs. And he had ask for another load of food when he had got some food a couple of days (or more) before and the money he was asking for or forcing for again he had before. And his sister had not lend him money and then after a while that because of the problem his brother Carlos had not give him any more money and his sister and when Tolio had then ask for another bag of food Carlos would said he would still send him some food and whatever he does with the food its his etc. and he had sold some food then for some drugs and he had some more because there was some people in there that needed some food to eat and he had got his share this way from food for drugs and what he can get for some of his food he had and he would or could give or sell. He had too been really sick before when he had just went there and it was from blood problems (blood cluts) and because of from the drugs he took before and when he had got sick from that when he had turned pale or kind of green and and his body got some what fat or blown up some and one person there saw him his room and went outside and called out to the guards and others help him after knowing and they had to shake the gates too to wake up the guards who were outside the gates at their bunk rooms and the guards woke up and heard of this and checked and one guard call the ambulance and knowing them would had him picked up and send him and to have him on aid or care there the doctor or one of the guard had him sent right away and so he can have care for that soon and there at the doctors and his brother had heard of that and went to the hospital after they called him and had him for his stay or hospitality there and had a charge for the family for this. The family had provide

money to him too for his medications and when he asked for some money for one medication he really needed or to buy it and the family (his brother Carlos or one of his sister) they had went lower of cash from buying medications for him and Carlos had no money to spend to buy another medication for him then till his next pay and he would need it within 3 days and the family knew and they were gonna get it for him on the third day or all try to get it for him no more than one day late and they could take it too him soon and then Carlos had borrowed from his son Carlos Jr. through deposit to one bank or other cash checking store and when it was sent he had got the amount and it was later in the day at the third day and or early in the morning he went to pick it up at the bank and left that day to take it to buy the pills at Tijuana for Tolio and when he went there(I had went with him) Tolio wasnt there(at La Presa) and his half-sister said he had left earlier to borrow some money from his friends to buy the medicine and because he wasnt there and left to borrow money we left later and used some of the money for gas. And the next day or a couple days He had called Carlos that he had said before and he had said to him to bring him to San Diego when he was at home and when he came back from borrowing money and from his friends or doctors and when he had told him something similar before Carlos wouldnt take him back because he knew his brother Tolio had been in trouble by the law in the U.S. in San Diego and he was wanted by the law in San Diego. And even though he was wanted at La Presa Tijuana before he was living in San Diego then. They had a wanted sign with his picture on it and posted all over the town from the telephone poles on closed shops walls and other shops. And Carlos would take him to San Diego but the law or officers could of have him busted if they see him and crossing the boader with him is a chance that he could cross the boarder his he was wanted by court. A couple of days or so later at the home at Upper La Presa in his room of the small house he had passed away/died on his bed in the month of Feb. or March in 2010. The family got the decisions from the cause of his death and they said it wasnt from drugs he took then or for suicide for his cause of his own death it was from death that comes and he had been sick before for a while then and he was probably dying too that he died. The doctors said he did not have any drugs in his system thathe had token then. Something similar for Gardes cause for his death and when he had became stiff and paralyzed or froozen from his whole body and had dropped to the floor and died and it was the day his second own family had been there the same day.

The decision for the family to pay for Tolio funeral did not come to have a funeral for his burial or commorative(?) and his own daughter had decided to have the funeral literary and the family and her decided to have the wake at the family home at Upper La Presa on Cuautemoc st. Because of money they did not have a burial and they had for his body to be cremate/burned to ashes after they were gonna send his body away and when his daughter came and decided to have the church meeting and the wake for Tolio. And decisions that had came with the family before for a burial for him and the famliy had three recently family members funerals they had within 3 years and a few months since September(?) 2007.
